# Kansas Tax Credit Program Overview

## ACE SCHOLARSHIPS KANSAS OFFERS A 75% STATE TAX CREDIT FOR DONATIONS.



Annual contribution limit of \$500,000 per donor



Businesses and individuals with state income tax liability may contribute



\$10 million in credits available per year



85 ACE partner schools statewide



90% of each donation is used to fund scholarships

## WHAT HAPPENS TO THE DONATION?

- » ACE Scholarships uses it to provide scholarships for students at the lowest income levels to attend quality private schools.
- » ACE Scholarships processes your donation with the Kansas Department of Revenue and secures your 75% state income tax credit.

## WHAT ARE THE ADVANTAGES?

- » Donors can reduce or eliminate their Kansas state tax liability.
- » In addition to the 75% state tax credit, taxpayers that itemize may also be eligible to claim a partial charitable contribution deduction on their federal income taxes.

## (CONT.)

- » Donations to ACE Scholarships are accepted anytime, and a non-refundable state income tax credit is earned when a donation is made. Any unused tax credits may be carried forward for future tax years.
- » A taxpayer can donate to ACE quarterly, monthly, or in one lump sum. A taxpayer may donate at whatever frequency they desire, so long as the full donation is made before December 31st in order to claim the tax credit for this tax year.

## WHO IS ELIGIBLE?

- » Students attending a Kansas public school or entering kindergarten are eligible. In order to receive a new scholarship, students must be in grades K-8. Once awarded, students can keep their scholarships through high school.
- » Additionally, the household income of the student's family must be 250% of federal poverty guidelines or lower to qualify.

## WHO IS ACE?

- » ACE Scholarships is a 501(c)(3) charitable organization with a close to 25-year track record of success in 12 states across the country.
- » Since starting in Kansas in 2016, ACE Scholarships has provided approximately 3,000 scholarships totaling over \$6.9 million worth of investments in students throughout the state.
- » ACE Scholarships students attain higher graduation rates and ACT scores and matriculate to college and post-secondary education at a rate much higher than their peers.
- » By helping students attend ACE partner schools, you are helping keep the Kansas K-12 private education sector strong and allowing these schools to reach more kids each year.

Speak to your CPA or tax advisor about your expected tax liability for the year. (Remember that unused credits can be carried forward for future tax years!)

Your gift is eligible for a tax credit in 2024 until midnight on December 31, 2024. Checks dated January 1, 2025, or later will qualify for a 2025 tax credit.



ACE will submit credit requests to the Kansas Department of Revenue for each donation. Once the donation is approved, a receipt for the approved credit amount will be issued to be filed with the donor's tax returns.

# Kansas Tax Credit for Low-Income Students Commitment Form

ACE Scholarships SGO Kansas, LLC, is an approved Scholarship Granting Organization (SGO) participating in the Tax Credit for Low-Income Students Scholarship Program. The program provides a 75% state tax credit to taxpayers or corporations filing Kansas income tax returns (e.g. individuals, corporations, nonprofits, and other exempt organizations) that donate to certified SGOs. ACE Scholarships SGO Kansas, LLC, will automatically allocate 90% of each taxpayer's contributions to fund qualifying student scholarships. Eligible taxpayers can contribute up to \$500,000 in one calendar year. Unused credits can be carried forward for future years. ACE Scholarships SGO Kansas is not responsible for verifying donor eligibility. To receive a credit, interested parties should verify eligibility with a certified tax accountant or the Kansas Department of Revenue.
