# Louisiana Tuition Donation Tax Credit Program Overview

## WHAT IS THE TUITION DONATION TAX CREDIT PROGRAM?

- » The Louisiana Legislature established the Tax Donation Credit program to empower families with financial resources to choose the school that works best for their child.
- » Through the TDC program, any individual or corporation with state income tax liability is eligible to donate to ACE Scholarships Louisiana and receive a 95% state income tax credit.

## WHO IS ACE?

- » ACE Scholarships Louisiana is a 501(c)(3) charitable organization that provides needs-based tuition scholarships to K-12 students from lower-income families.
- » Since 2014, ACE has provided nearly 13,900 scholarships totaling over \$58.5 million worth of investments in students throughout the state.

## PROGRAM OVERVIEW



All Louisiana businesses and individuals may contribute



No annual contribution limits



Every dollar donated generates a 95% state income tax credit



95% of each donation is used to fund scholarships



Nearly 200 ACE partner schools statewide



Provides tuition scholarships for students from low-income families (250% of federal poverty guidelines)



Students attending a Louisiana public school or entering kindergarten are eligible

## WHAT HAPPENS TO THE DONATION?

- » ACE Scholarships uses it to provide scholarships for students at the lowest income levels to attend quality private schools.
- » ACE Scholarships processes your donation with the Louisiana Department of Education and secures your 95% state income tax credit.

## WHAT ARE THE ADVANTAGES?

- » Donors can reduce or eliminate their Louisiana state tax liability.
- » In addition to the 95% state tax credit, taxpayers that itemize may also be eligible to claim a partial charitable contribution deduction on their federal income taxes.
- » Donations to ACE Scholarships Louisiana are accepted anytime, and a non-refundable state income tax credit is earned when a donation is made. Any unused tax credits may be carried forward for three years.

## HOW DO DONORS BENEFIT?

- » The following examples illustrate the potential impact of individual donations under a variety of tax rates and scenarios. Consult your tax advisor for details on your own tax circumstances and strategy.

### Net Cost of Gift at Various Donation Amounts

Donation Amount	\$10,000	\$50,000	\$100,000
State Tax Credit	(\$9,500)	(\$47,500)	(\$95,000)
Net Federal Tax-Deductible Gift	\$500	\$2,500	\$5,000
Tax Bracket	24%	35%	35%
Federal Tax Savings	(\$120)	(\$875)	(\$1,750)
Net Cost of Gift	\$380	\$1,625	\$3,250

# How To Donate to ACE Scholarships Louisiana & Receive a 95% State Tax Credit:

- 1 Speak to your CPA or tax advisor about your expected tax liability for the year. Credits are applied to the year in which the donation is made. Any unused credits may be carried forward for up to three years.
- 2 Make a donation to ACE Scholarships Louisiana via check, wire transfer, stock shares, or credit card before the year's end. Donor instructions are on the next page. **Prefer to speak with someone directly?** Call ACE Scholarships today at (504) 458-5180.
- 3 Complete the Louisiana Donation Tax Credit Form, which is also available online at: <https://qrco.de/lapledgeform>. Return the completed form to ACE Scholarships Louisiana via email at [mlandry@acescholarships.org](mailto:mlandry@acescholarships.org).
- 4 ACE will use your contribution to provide needs-based scholarships to deserving students across Louisiana. ACE will mail you tax receipts that can be applied to your state and federal income tax filing.

# Louisiana Tuition Donation Tax Credit (TDC) Form

ACE Scholarships Louisiana, LLC, is an approved School Tuition Organization (STO) participating in the Louisiana Tuition Donation Credit (TDC) program. The program offers a state income tax credit to individual taxpayers or corporations that donate to certified STOs. ACE Scholarships Louisiana, LLC, will automatically allocate 95% of each taxpayer's contributions to fund qualifying student scholarships. As a result, an eligible taxpayer who gives a scholarship donation to ACE Scholarships Louisiana can claim a 95% credit. A donor must be required to file a Louisiana tax return; ACE Scholarships Louisiana is not responsible for verifying donor eligibility. Credits are nonrefundable, but any credit earned in excess of annual tax liability can be carried forward for up to three tax years.
